Product and Company Identification

- <u>Product name:</u> Songbird Massage Wax Sports
- <u>Uses:</u> This product is a massage medium. It can be used as a moisturizer.
- **Supplier:** Songbird Naturals Ltd (Co No: 5820629)

Information on Hazardous Ingredients

- This is a blend of natural ingredients and the blend has no known hazards.
- Essential oils are below hazard percentage.
- Eye Contact Low hazard. Irrigate with tepid/warm water.
- Skin contact It is a product for use on the skin and no known hazard is present.
- Ingestion data not available but the constituent ingredients are low hazard at this level for ingestion unless there is a nut allergy present (Almond Oil). If accidentally ingested, seek medical advice.
- Contains nut oil. This may present a hazard to nut allergic persons.

Handling and Storage

• Good practice in hygiene is applicable for handling. Caution when handling the pot with the product on the hands as it is slippery.

• Product should ideally be stored at room temperature (20-23 degrees) or below. It will tolerate higher temperatures for short periods of time, but will become softer. If this is prolonged, or is much higher in temperature, the product may become more liquid than semi-solid. Performance may be impaired in this state.

Physical Properties

- <u>Visual Identification</u>: Product is a semi-solid blend of natural oils and waxes. It is yellow to dark yellow in colour.
- <u>Touch Identification</u>: The product is waxy/oily and should spread easily on application to the skin.
- <u>Odour:</u> The characteristic odour of the Sports Massage Wax is lightly Lemon/Olive.
- Flashpoint: N/A
- Stability and Reactivity
- Heat promotes oxidation and should be avoided.
- Rancidity would be indicated by a rank/rancid odour. Under normal room temperature storage and usage conditions the product is generally stable and not prone to rancidity.
